A candidate, to be eligible for nomination as an officer or director, shall be a member of a USBC sanctioned league during the current season and must not be bowling in any unsanctioned leagues. A candidate for director must have been a member of ABC, WIBC, and/or USBC Associations for at least three years. An officer or director must be a member of the local association at the time of election and throughout their term of office.

To be eligible for a line officer position in the Napa-Sonoma local association, a candidate shall have served at least one year on the board of directors or one complete term during the five year period immediately preceding the nomination.
